## **SPA MEMBERSHIPS**

Plan Details: Coastal Skin Care will provide you, the member, a treatment every month for 6 months at a discounted price. The agreement may be cancelled in 3 months with no penalty. Gratuities are not included and we ask you to consider the full price value of your services. This Membership pricing plan, may not be combined with any other promotion or discount, including but not limited to SpaFinder redemption, Axxess cards or private promotional discounts. Memberships may not be paid for with gift cards purchased during promotions.

- Memberships are automatically charged to your credit card once per month, with a 6 month commitment. When the six month commitment concludes, your membership will auto-renew on a month to month basis if we don't hear from you to terminate it.
- If you don't use your service credit in one month, you keep your unused treatment for the next month. Up to two months' service credits may carry over from the previous months, until the end of the 6 month agreement.
- Memberships are not transferable.
- Gratuities are not included; please consider the full price value of your massage session.
- We are happy to provide you with a "Member for the Day" Guest Pass for someone *new* to Coastal Skin Care Day Spa. They'll enjoy a member discount on any treatment for that day.
- Our memberships cannot be purchased with SpaFinder, or combined with any other promotional offers, including, gift certificates.
- We are happy to provide a copy of this Membership Agreement, including all terms and conditions, prior to your purchase. Coastal Skin Care Day Spa reserves the right to change its policies and pricing at any time upon reasonable written notice.

### **COASTAL SKIN CARE MEMBERSHIP PROGRAM BILLING AGREEMENT**

If credit card payment is unable to be processed for insufficient funds or card error, there will be a \$15 per month late fee.

- b. Service credits not used in one month carry over from month to month until the end of the contract. At that time, all unused services will expire within 2 months. Services not used will be forfeited at that time.

- d. Coastal Skin Care Day Spa recommends scheduling appointments 4 weeks in advance for best selection of time and service provider.
- e. It is understood that services are not transferable.
- f. The guest may terminate the contract for compelling medical reasons with physician's statement, without penalty.
- g. Contract may be terminated if guest moves more than 30 miles from Coastal Skin Care Day Spa, without penalty.
- h. Membership can be suspended temporarily if guest is physically unable to visit the spa.
